Tender Terms & Conditions: Pest Control Services

1. Scope of Work & Frequency

- **Treatment Coverage:** Full coverage of all indoor and outdoor areas within the Shilparamam Madhapur, including stall areas, administrative offices, food courts, Sampradayavedika and Dining Hall, Village Museum, Guest Houses, Amphitheatre, Ethnic Hall, store rooms, washrooms, and surrounding grounds.
- **Target Pests:** Comprehensive control of termites, wood-borers, rodents (rats/mice), mosquitoes, flies, cockroaches, ants, snakes, and stray pest nuisances.
- **Frequency:**
 - **Routine Treatments:** Minimum twice-a-week or weekly routine sprays and rodent baiting, as decided by Shilparamam management.
 - **Major/Fogging Operations:** Bi-weekly fogging/mosquito control and regular sub-soil/wood termite inspections.
 - **Emergency Calls:** Immediate response (within 3 hours) for unscheduled or severe pest infestations at no additional cost.

- **Chemical Standards:** Only Central Insecticides Board (CIB) approved, eco-friendly, odourless/low-toxicity, and non-hazardous chemicals suitable for high-footfall public and heritage zones must be used.
- Supply of Chemicals for Mosquito Spray, Fogging, Rat Control, Snake Control, Termite Control, Butane Gas etc. and NT Quito Chemicals, Delta Fog, Premise Termite etc.

2. Eligibility Criteria for Bidders

1. **Statutory Pest Control License:** Must hold a valid Commercial Pest Control License issued by the competent State Agriculture/Insecticide Licensing Authority.
2. **Experience:** Minimum **3 years of experience** providing pest control services to government bodies, public parks, heritage/cultural centres, hospitality venues, or large commercial complexes.

3. EMD & Security Deposit

- **Earnest Money Deposit (EMD):** Bidders must submit an EMD for Rs. 10,000/- Demand Draft (DD) drawn in favor of "**Special Officer, Shilparamam, Hyderabad**". Bids submitted without EMD will be summarily rejected. Unsuccessful EMDs will be refunded within 15 days of tender finalization.
- **Security Deposit:** The successful agency shall furnish an interest-free Security Deposit.

4. General Operational Terms

- **No Subcontracting:** The agency shall not assign, transfer, or sub-contract any part of the service to third parties.
- **Equipment & Materials:** The contractor must supply all required equipment (fogging machines, spray pumps, rodent stations, safety gear) and chemicals/pesticides at their own expense.
- **Safety & Liability:**
 - The agency is solely responsible for the safety and health of its deployed personnel.
 - The agency must comply with all statutory labor laws (Workmen's Compensation Act, Minimum Wages Act).
 - Shilparamam management bears no liability for injuries, accidents, or statutory default by the service provider.
- **Site Inspection:** Bidders are advised to visit the Shilparamam Madhapur and assess the area, layout, and extent of work before submitting financial quotes.

5. Payment & Termination

- **Billing:** Monthly bills must be submitted along with service logs signed by designated Shilparamam authority officers, along with proof of statutory remittances (GST).
- **Termination Clause:** Either party may terminate the contract by giving **one (1) month's prior written notice**. In the event of unsatisfactory performance or breach of terms, Shilparamam reserves the right to terminate immediately and forfeit the Security Deposit.
- **Right to Accept/Reject:** The **Special Officer, Shilparamam** reserves the right to accept or reject any or all tenders without assigning any reason.
